

# PRIVACY POLICY

## INTRODUCTION

This Privacy Policy applies to FCP LLC the provider of the website: [www.freecashprofit.com](http://www.freecashprofit.com) (hereinafter referred to a “Free Cash Profit”, “[www.freecashprofit.com](http://www.freecashprofit.com)”, “Free Cash Profit LLC”, “we”, “us” or “our”). Making information secure and private is significantly important to us at FCP LLC. We are familiar with the importance of protection the privacy of information collected about our users, and we operate in accordance with applicable data protection law. This privacy policy (this “Privacy Policy”) is intended to help you recognize how we gather, use, and disclose information that you (hereinafter referred to as “you”, “your”, “User” or “Visitor”) provide to us by visiting our sites, and with whom information is shared. This Privacy Policy applies to all FCP LLC maintained websites, domains, merchant services and merchant portals, stored value and loyalty programs and other channels, and other online resources (the “Sites”), though because of the functionality of some of our Sites, additional terms and notices may be required.

This Policy aims to explain:

- how we collect, use, and share information from or about you;
- how our online advertisements (such as banner ads) on third-party sites treat data;
- your choices about our use of your personal information; and
- how you can access and update your information.

Due to the fact that the website is an evolving process and we may need to change this Policy, in whole or in part, at any time, with or without advance notice, by posting a new Policy in its place. Your continued use of the Site following any changes to this Policy will constitute your acceptance of such changes at the time of use. If you disagree with how we may use your information under this Policy, you should not use the Site, and henceforth must discontinue your usage.

## ACCEPTANCE OF POLICY

By using this Site, you signify your acceptance of this policy. If you do not agree to this policy, please do not use our Site. Your continued use of the Site following the posting of changes to this policy will be deemed your acceptance of those changes.

## INFORMATION COLLECTION AND USE

### Type of Information Collected.

We deem it important for you to know what type of information we collect when you use our site. Basically we collect Personally Identifiable Information (PII) and Non Personally Identifiable Information (NPII). The information collected may include your email, name, company name, street address, post code, city, country, telephone number, password, bank details etc. We collect this information in several different ways; to begin with, we use cookies that are needed to compile and aggregate non-personally identifiable information about the visitors to our web site. Personally identifiable information consists of information that is unique to you, such as credit card number and bank account numbers. The information is unique to you.

## **Information Collection**

We collect information from you in several different ways on this Site. One goal in collecting personal information from you is to provide an experience that is customized, efficient and meaningful. For example, we can use your personal information to:

- help make the Site easier for you to use by not having to enter information more than once.
  - help you quickly find information, products, and services.
  - help us create content that is most relevant to you.
  - alert you to new information, products, and services that we offer.
- i. ***Personally Identifiable Information (PII)***: PII means information or a combination of information that can be used to identify, contact, or locate a specific person. We collect personally identifiable information from you when you set up an account with [www.freecashprofit.com](http://www.freecashprofit.com). We may collect the following types of PII from you:
- Contact information, such as name, email address, mailing address, fax or phone number;
  - Payment and financial information, such as credit or other payment card information, bank details, or billing address;
  - Social Security Number or other National Tax ID Number
  - Device geo-location (geographical location)
  - Unique identifiers such as user name, account number, or password; and,
  - Preference information such as product wish lists, order history, or marketing preferences.

While you can browse some sections of our site without being a registered member, certain activities do require registration. We do use your contact information to send you offers based on your previous orders and your interests.

- ii. ***Non-Personal / Identifiable Information (NPPI)***: This type of information collected does not reveal your identity or directly relate to a person. We gather statistical and other analytical information collected on an aggregate basis of all visitors to our website. This Non-Personal Data comprises information that cannot be used to identify or contact you, such as demographic, the browser's name, the type of computer and technical information about Users, means of connection to our Site, such as the operating system, user Internet service providers "IP addresses" where they have been clipped or anonymised, browser types and other anonymous statistical data involving the use of our website. We may collect the following NPPI from you:
- Information about your business such as company name, company size, or business type;
  - Demographic information, such as age, gender, interests and ZIP code;
  - Device and other tracking information, such as browser information, device identifiers, operating system, or information gained from cookies, pixels or other tracking technologies.

## **How We Collect Personally Identifiable Information**

Your PII is only collected when you provide it to us. This can occur when you fill out applications, create accounts, complete a purchase, add money to your account, send in forms, take surveys, or fill in various online fields on our Sites. We also collect PII when you contact us with inquiries, customer support requests, etc. We may also collect the PII of third parties when you provide it to us.

## **Use and Disclosure of Information Collected**

We may use the Personal information we collect for the following purposes:

- (a) For Internal Use like processing your service, providing you with customer service. We may also use your provided information to improve the Sites' content and layout, to improve outreach.
- (b) For Communications with you, to inform you about the Site and your orders and service deliveries. Confirmation email might also be sent to you when you register with us, service-related announcement on rare occasions when it is necessary (for example, if we must temporarily suspend our service for maintenance.) etc.
- (c) For external use. In order to provide you with excellent service and to offer you user experience, we may disclose information to service providers, so as to help them to perform their service; We also disclose such information in response to requests from law enforcement officials conducting investigations; subpoenas; a court order; or if we are otherwise required to disclose such information by law. We also will release personal information where disclosure is necessary to protect our legal rights, enforce our Terms of Use or other agreements, or to protect ourselves or others. For example, we may share information to reduce the risk of fraud or if someone uses or attempts to use the Site for illegal reasons or to commit fraud.

### **Use of Non Personal Information**

We and certain third-party service providers with whom we have agreements may collect NPII in a variety of ways, including:

**Log file:** Most browsers collect certain information, such as your IP address, device type, screen resolution, operating system version, and internet browser type and version. This information is gathered automatically and stored in log files. We may link this data to PII we have collected about you.

**Cookies and Other Technology:** Like many sites, [www.freecashprofit.com](http://www.freecashprofit.com) employs cookies and web beacons (also known as clear GIF technology or "action tags") to speed your navigation of the Site, identify you and your access privileges, and also track your Site usage.

- (i) ***What are Cookies?*** Cookies are pieces of information stored as text files by your Internet browser on your computer's hard drive. Most Internet browsers are originally set to allow cookies but you can set your browser to reject cookies from web sites or to remove cookies from your hard drive. Note, if you do set your browser to reject cookies, you will not be able to access or use some features or portions of the website. Finally, THIS SITE'S COOKIES WILL NOT AND CANNOT INFILTRATE YOUR HARD DRIVE TO GATHER CONFIDENTIAL INFORMATION. Our cookies are not "spyware."
- iii. ***Web beacons*** assist in delivering cookies and help us determine whether a web page on the Site has been viewed and, if so, how many times. For example, any electronic image on the Site, such as an ad banner, can function as a web beacon.
- iv. We may use third-party advertising companies to help tailor site content to users or to serve ads on our behalf. These companies may employ cookies and web beacons to measure advertising effectiveness (such as which web pages are visited or what products are purchased and in what amount). Any information that these third parties collect via cookies and web beacons is not linked to any personal information collected by us.
- v. As an example, social Medias collects certain information via cookies and web beacons to determine which web pages are visited or what products or services are purchased. Please note that any information collected by social Medias via cookies and web beacons is not linked to any customer's personal information collected by us.

## DISCLOSURE AND EXTERNAL USE OF YOUR PERSONAL INFORMATION

Except as described in this Privacy Policy, personal information you provide to us will not be shared with or used by third parties without your permission.

1. **Service providers.** We contract with other companies to provide services on our behalf, such as shipping orders, fulfilling certain orders, processing payments, hosting our Site and product review pages, sending out information or promotional offers, providing customer service and analyzing data from our Site. We provide these companies with only those elements of your personal information that they need to deliver those services. These companies and their employees are prohibited from using that personal information for any other purpose.
2. **Aggregate Data.** We may share aggregated, non-personal data with service providers, advertisers or other existing or potential business partners to enable our users to receive targeted information (such as product recommendations) and/or discounts and to optimize third-party offers of products and/or services.

We will disclose your personal information to the partner companies when you consent to that disclosure, including consent implied by your agreement to the applicable membership or participation rules. And then we will disclose only the personal information required to make these programs work for you and support your membership in them.
5. **Acquisitions or divestitures.** We may decide to sell, buy or merge our own or other businesses. Such a transaction may involve the disclosure of personal and other information to prospective or actual purchasers, or receiving it from sellers. It is our practice to seek appropriate protection for information in these types of transactions. In the event that we or all of our assets are acquired in such a transaction, customer information would be one of the transferred assets.

## DATA SECURITY

We incorporate several procedures to safeguard the confidentiality of your personal information, including Secure Sockets Layer (“SSL”) for all financial transactions through the Site. We use SSL encryption to protect your personal information online, and we also take drastic measures to protect your personal information in our facilities. Access to your personal information is restricted. Only employees who need access to your personal information to perform a specific job are granted access to your personal information. **NOTE:** Because we use industry-standard safety measures
